TITLE: Award Contract for Employee Benefits Consulting and Actuarial Auditing

I. MOTION REQUESTED

A) Award Request for Proposal No. RFP230620CJV, Employee Benefits Consultant and Actuarial Auditor to Aon Benefits & Insurance Services, Inc. for employee benefits consulting and actuarial auditing, on an as needed basis, for an initial term of three years, in the amount of \$192,000 annually.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to renew the contract, for up to two additional years, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County.

II. ITEM SUMMARY

Awards a contract to the top ranked firm, Aon Benefits & Insurance Services, Inc, for employee benefits consulting and actuarial auditing commencing on October 1, 2024. The initial contract is for three years with up to two additional one year renewals.

Total expenditures for FY24-25 are expected to be \$192,000.

RFP230620CJV was advertised and published on February 13, 2024. On the due date of March 14, 2024, the County received and opened four proposals.
