Dear Mr. Michaels:

This notice is to inform you that Lee County has elected to terminate the piggyback agreement, Solicitation No. PB200090ANB, which was piggybacking off Brevard County Board of County Commissioners, Contract Number RMS159262, for Ground Medical Transport Billing Services. Pursuant to Article 21.0 TERMINATION of the Service Provider Agreement entered into between Change Healthcare Technology Enabled Services, LLC and Lee County on January 24, 2020, the County is providing a ninety-day advance written notice of termination.

During this ninety-day period Change Healthcare Technology Enabled Services, LLC will complete servicing of the remaining Lee County accounts that were assigned to them through February 15, 2024, prior to their data breach. As of issuance of this notice no new accounts will be placed with Change Healthcare Technology Enabled Services, LLC. However, this agreement will only terminate after completion of servicing for the remaining assigned accounts.
