LIQUIDATED DAMAGES (CONSTRUCTION)

In accordance with the terms set forth in the Agreement, for each consecutive calendar day of delay in achieving Substantial Completion as set forth herein, the Contractor shall be liable to the County for liquidated damages in the amount of \$882.00 per calendar day.

BASIS OF AWARD

The basis of award shall be determined by the lowest *Project Total* of the most responsive, responsible, and qualified CONTRACTOR meeting all bid specifications.

LOCAL PREFERENCE

The Lee County Local Vendor Preference shall be included as part of the award process for this project. As such, Lee County at its sole discretion may choose to award a preference to any qualified Local Vendor.

BOND REQUIREMENTS

Bond requirements shall abide by the current Lee County Procurement Ordinance, Construction General Conditions, and apply only to projects over \$200,000.

- **Bid Bond** Contractor shall submit Bid Bond in the amount of not less than five percent (5%) of the proposed dollar amount (including Alternate(s), as applicable, and shall accompany each submission.
- **P & P Bond** Awarded Contractor shall provide Performance and Payment Bonds in the amount of one hundred percent (100%) of the total Awarded Contract amount after notification by the County of the approval to award the Contract, the costs of which are to be paid by the awarded Contractor.

INSURANCE REQUIREMENTS

Insurance shall be provided by the awarded bidder/vendor. Prior to execution of the Agreement/Contract a certificate of insurance (COI) complying with the bid documents shall be provided by the bidder/vendor. The Lee County Board of County Commissioners seeks to contract with a qualified CONTRACTOR to construct, provide, deliver, and install a new modular building, including stairs, railings, bathrooms, and other items at the Lee County Solid Waste Facility located at 10550 Buckingham Ft. Myers, FL 33905.
