

FIRST AMENDMENT OF PROFESSIONAL SERVICES AGREEMENT

THIS FIRST AMENDMENT OF THE PROFESSIONAL SERVICES AGREEMENT FOR MISCELLANEOUS PROFESSIONAL SERVICES, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Halff Associates, Inc. dba Singhofen Halff ("Consultant"), collectively, the "Parties."

WHEREAS, the County entered into a professional services agreement for the purchase of miscellaneous professional services through Solicitation CN200224JJB with Consultant on the 16th day of December, 2020 ("Agreement"); and,

WHEREAS, on the date the Agreement was executed, the Consultant's business entity name was Singhofen & Associates, Inc., with a Federal Tax ID Number of 59-2341111; and,

WHEREAS, after execution of the Agreement, Singhofen & Associates, Inc. merged with Halff Associates, Inc. and began operating as Halff Associates, Inc. dba Singhofen Halff, with the Federal Tax ID Number of 75-1308699; and,

WHEREAS, County and Consultant desire to enter into this First Amendment to continue their Agreement via Solicitation No. CN200224JJB under the Consultant's new business name.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Consultant, conducting business as Halff Associates, Inc. dba Singhofen Halff, shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. CN200224JJB, including appendices and amendments, and Consultant's response.
