

FIRST AMENDMENT OF PROFESSIONAL SERVICES AGREEMENT

THIS FIRST AMENDMENT OF THE PROFESSIONAL SERVICES AGREEMENT FOR PLUMBING, HVAC, AND ELECTRICAL ENGINEERING SERVICES - ANNUAL, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Quantum Consultancy LLC ("Consultant"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of plumbing, HVAC, and electrical engineering services through Solicitation CN230600JJB with Consultant on the 22<sup>nd</sup> day of March, 2024 ("Agreement"); and,

WHEREAS, on the date the Agreement was executed, the Consultant's business entity name was Diversified Technology Consultants, Inc., with a Federal Tax ID Number of 06-1011119; and,

WHEREAS, after execution of the Agreement, Diversified Technology Consultants, Inc. decided to discontinue operations and transferred and assigned its staff, assets, and projects to Quantum Consultancy LLC, with a Federal Tax ID Number of 99-1098182; and,

WHEREAS, pursuant to ARTICLE 9.00 - ASSIGNMENT, TRANSFER AND SUBCONTRACTS, County and Consultant desire to enter into this First Amendment to continue their Agreement via Solicitation No. CN230600JJB under the Vendor's new business name.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Consultant, conducting business as Quantum Consultancy LLC, shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. CN230600JJB, including appendices and amendments, and Consultant's response.


