The following represents clarification, additions, deletions, and/or modifications to the above referenced bid. This addendum shall hereafter be regarded as part of the solicitation. Items not referenced herein remain unchanged, including the response date. Words, phrases or sentences with a strikethrough represent deletions to the original solicitation. Underlined words and bolded, phrases or sentences represent additions to the original solicitation.

1. QUESTIONS/ANSWERS

1.	Could you confirm that the licensure and certifications requested under Tab 4 are also excluded from the page limit?
Answer	Resumes, licensure and certifications are not included within the page restrictions. Resumes should be limited to one (1) page per person.

2.	On the Lee County Document Management Form chart (pg. 56) , Form 12 is listed as the <i>Disclosure of Lobbying Activities</i> form. However, the <i>Disclosure of Lobbying Activities</i> form found on pg. 75 is listed as <i>Form 11a</i> and the following form is listed as <i>Form 12 continued – Instructions for Completion of Self Disclosure of Lobbying Activities</i> . Could you verify that these forms are accurate and that <i>Form 12 continued</i> does not require a signature?
Answer	Pages 75 and 76 of the solicitation is FDOT form # 375-030-34 in its entirety. The first page is identified as Form 11a. The second page is identified as Form 12 continued. This is duly noted as a formatting error. However, Proposers shall continue to utilize page 75 and complete as applicable. Page 76 of the solicitation remains as Form 12 continued and act as instructions to Form 11a. Form 12 does not require a signature.

3.	Can you confirm if licensure, certifications, and the org chart are included in the page restrictions?
Answer	Resumes, licensure and certifications are not included within the page restriction. Resumes should be limited to one (1) page per person. An org chart is not being requested; however, will be accepted within Tab 4 and not counted towards the page restriction.

4.	Are there any FDOT-required pre-qualifications?
Answer	There are no FDOT-required pre-qualifications for this solicitation. However, Section 12 – “Personnel” on page 42 of the solicitation, does identify desired qualifications, but not to be considered as minimum qualifications.

5.	Would the County consider increasing the page limit? The RFP currently allows only five pages, whereas past pursuits have been in the range of 8–10 pages.
Answer	The page restriction remains five pages.

6.	If the overall page limit remains unchanged, would the County consider excluding the organizational chart and availability graphic from the page count?
Answer	An organizational chart or availability graphic has not been requested by the County; however, will be accepted within Tab 4 and not counted towards the page restriction.
