	This morning we saw Addendum 1 which added a form which is requesting

2.	certification from FDOT as to prequalifications. Pursuant to our FDOT Prequalification letter, sharing of the indirect costs is prohibited. Therefore, we would like to propose that we provide the verification printout from FDOT's consultant qualification website.
Answer	The qualification certification from the Florida Department of Transportation (FDOT) does not request any indirect cost or financial information from the Consultant/Sub-Consultant. Per Revised Form #15 – Minimum Qualification Requirements, the COUNTY is requesting a copy of either the Prime Consultant or Sub-Consultants Certificate of Qualification letter provided by FDOT showing proof of being certified in the work classes described in Criteria 1.
