TITLE: Award Annual Contract for Water Plant Cartridge Filters

### I. MOTION REQUESTED

- A) Award Invitation to Bid No. B210519MIF, Cartridge Filters for Water Plants Annual to Harn R/O Systems, Inc. as primary vendor and Tri-Dim Filter Corporation as a secondary vendor to furnish and deliver 5-Micron Cartridge filters to Lee County Water Treatment Facilities, on an as-needed basis, for an initial term of one (1) three-year period, as approved in the departments' annual adopted budget.
- B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C) Grant the County Manager or designee the authority to renew the contract, for up to three additional years, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no-cost increases associated with the renewal.

## II. ITEM SUMMARY

Awards competitively bid contracts to Harn R/O Systems, Inc. as primary vendor, and Tri-Dim Filter Corporation as a secondary vendor, for filters used to remove particulates from raw water prior to Reverse Osmosis processing. The initial contract is for a three-year period, with an option to renew for up to three additional years. Total expenditures for these services for the prior twelve-month period were \$83,310.

Procurement Management obtained bids for the project, known as Invitation No. B210519MIF, Cartridge Filters for Water Plants - Annual. On the bid deadline of December 3, 2021, Procurement Management received three bids. After analyzing the bid submittals, Harn R/O Systems, Inc. and Tri-Dim Filter Corporation were determined to be the lowest responsive and responsible bidders.

5 Micron filters are used in County water treatment facilities for the pre-filtration of raw water to remove particulates prior to the Reverse Osmosis process. Utilities budgets an annual amount based on annual projected water production.
