TITLE: Award Contract for Control, Telemetry, Security, Instrumentation, and SCADA Integration Services

#### I. MOTION REQUESTED

A) Award Request for Proposal No. RFP240113DWJ, Control, Telemetry, Security, Instrumentation, and SCADA Integration Services to U.S. Water Services Corporation for the purchase of control, telemetry, security, instrumentation, and SCADA integration services on an as-needed basis for an initial term of three (3) years, as approved in the departments' annual adopted budget. Individual purchases in excess of \$100,000.00 will be presented to the Board for approval.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to renew the contract, for up to two (2) additional one (1) year periods, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewal(s).

### II. ITEM SUMMARY

Awards competitively bid contract to U.S. Water Services Corporation to provide system-wide control, telemetry, security, and SCADA integration services on an as-needed basis, for an initial term of three years and the option to renew for up to two additional years. SCADA systems are computer-based and used to collect, analyze and visualize data. These services are used to perform repairs to existing equipment and for the installation of new equipment for the controls, telemetry and security systems at the water and wastewater facilities. Total expenditures for the prior twelve-month period were \$175,764.32.

#### III. BACKGROUND AND IMPLICATIONS OF ACTION

Procurement Management obtained proposals for the project, known as Request for Proposal No. RFP240113DWJ, Control, Telemetry, Security and SCADA Integration Services for control, telemetry, security and SCADA integration services for Lee County Utilities. On the proposal deadline of February 22, 2024, Procurement Management received two proposals with one proposal being deemed non-responsive. On April 3, 2024, the evaluation committee met and reviewed the responsive proposal. The committee recommends awarding the contract to U.S. Water Services Corporation.
