- C. Grant the Director of Procurement Management the authority to negotiate and execute renewals of the contract, with County Administration approval, for up to three additional one-year periods, under the same terms and conditions, if doing so is in the best interest of Lee County.

WHAT ACTION ACCOMPLISHES:

Award Invitation to Bid No. 170000DKR to Associated Fuel Systems, Inc. for LeeTran's use on an as needed basis for Cummins remanufactured engines for the bus fleet. This project was planned and budgeted. The awarded contract will be for two years with three optional one year extensions under the same terms and conditions. Expenditures of these services totaled approximately \$81,216 during Fiscal Year 2015-2016.

Procurement Management advertised to obtain bids for Cummins remanufactured engines to fulfill the needs of LeeTran. On the bidding deadline of January 27, 2017, Procurement Management received one bid.
