	Full-time consists of 40 hours per week, 8 hours per day. Red lines shall be

Answer	Lee County will provide startup services for the control panel. The County will
mower	also program the PLC (Scada Pack) HMI and cell modem.

3.	Please confirm that the equipment replacements will all be like-for-like, and
	that the sites will not have any flood hardening improvements.
	These sites will need to meet the normal LCU lift station standards that can be
Answer	downloaded from the Utilities website. No additional flood hardening
	improvements will be required.
4.	There's a price component to provide a price, is that based on the documentation with
	the project solicitation, its not a fixed price? It's just a price per what's listed in the
	evaluation criteria?
Answer	The terms and conditions of this contract are fixed price and fixed time. The
	Design-Builder's submitted Price Proposal is to be a lump sum amount for
	completing the Scope of Work in this Solicitation. The Design-Builder will

provide a Schedule of Values to the County for their approval. The total of the
Schedule of Values will be this lump sum Contract Price for the Work.

5.	Are there any other consultants involved with the project within the County?
Answer	No, there are no other consultants involved with the project within the County.

6.	What is the timeline and duration of the project?
Answer	From the Notice to Proceed or the Purchase Order date, whichever applies: 540 calendar days to substantial completion, 45 calendar days to final completion (total calendar days 585).

7.	Is there a list of repairs that need to be completed at each lift station?
Answer	Please refer to Appendix C – FEMA DDDs for a list of proposed repairs.

8.	Will there be signed and sealed engineering plans required for removing of control
	panels for the lift stations?
Answer	Lee County will not require sign and sealed plans for the demolition of the site.

9.	There is a budget of \$1.4 million, does that already include the equipment you have already purchased?
Answer	Lee County will be providing the control panels, J-Boxes, and the lift station generator for the project. These items are not included in the current budget.
