I. MOTION REQUESTED

A. Award Invitation to Bid No. B210228DWJ, Ford OEM (Original Equipment Manufacturer) Repair Parts to Sam Galloway Ford, Inc., for the purchase of Ford OEM repair parts, on an as needed basis, for an initial term of three years, as approved in the departments' annual adopted budget. Individual purchases in excess of \$100,000.00 will be presented to the Board for approval.

B. Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C. Grant the County Manager or designee the authority to renew the contract, for up to three additional years, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewal.

II. ITEM SUMMARY

Awards a competitively solicited contract to Sam Galloway Ford, Inc. for the purchase of original equipment manufacturer parts (OEM) and supplies on an as-needed basis, for an initial term of three (3) years as approved in the department's annual adopted budget. The expenditure total for these services for Fiscal Year 20-21 was \$298,647. Expenditures of \$298,000 are planned in the Fiscal Year 21-22 budget. Sam Galloway Ford, Inc. provides the highest discount percentage, after application of local vendor preference of cost plus and was determined to be the most responsible and responsive bidder.
