II. ITEM SUMMARY

Approve extensions of the annual contracts with two firms under Bid No. B-130173, Annual Purchase of Fuel, for an additional six-month period, through November 15, 2018, for the annual purchase of fuel Countywide as approved in the departments' annual adopted budget. Total expenditures for these services during the 2016 - 2017 Fiscal Year were approximately \$3,601,053.14.

On May 7, 2013, the Board of County Commissioners awarded Countywide Bid No. B-130173, Annual Purchase of Fuel. The original term of the contract was for two years with three additional one-year renewal options. Board approval will allow for a six-month extension, through November 15, 2018, so that services will continue uninterrupted until a new contract is solicited.

Expenditures for these services during the 2016 - 2017 Fiscal Year total approximately \$3,601,053.14 Countywide.
