TITLE: Approve Contract Amendment for Group Medicare Advantage Plan

I. MOTION REQUESTED

A) Approve Amendment No. 1 to the contract with Aetna Life Insurance Company, now known as Aetna Health Management, LLC, under Solicitation No. RFP210280CJV, Group Medicare Advantage Plan, to incorporate the "Lee County Board of County Commissioners 2022 – 2024 Medicare Advantage and Part D Rate Guarantee," which was originally received from Aetna Life Insurance Company's initial proposal, into the contract as a rate exhibit. This amendment will also assign the agreement to Aetna Life Insurance Company's new entity, Aetna Health Management, LLC. This amendment will set the Medicare Plan 2024 Guaranteed Monthly Rate, at \$324.56 (4% increase), with total anticipated expenditures for Fiscal Year 2023-2024 in the amount of \$2,523,779. Total expenditures during Fiscal Year 2022-2023 were \$2,369,465.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

II. ITEM SUMMARY

Approves a contract amendment with Aetna Health Management, LLC, under the solicitation for Group Medicare Advantage Plan. The amendment will incorporate the "Lee County Board of County Commissioners 2022-2024 Medicare Advantage and Part D Rate Guarantee" into the contract as a rate exhibit. This amendment will also assign the agreement to Aetna Life Insurance Company's new entity, Aetna Health Management, LLC.

This amendment will set the Medicare Plan 2024 Guaranteed Rate, at \$324.56, which is a 4% increase. Anticipated expenditures for FY 23-24 are \$2,523,779 (employer premium \$1,514,267/retiree premium \$1,009,512).

Total expenditures for Fiscal Year 22-23 were \$2,369,465 (employer premium \$1,421,679/retiree premium \$947,786).

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

On September 21, 2021, the Board of County Commissioners awarded RFP210280CJV, Group Medicare Advantage Plan, to Aetna Life Insurance Company to provide the retiree Group Medicare Advantage medical and pharmacy benefits plan, on an as needed basis. The original term of the contract was for 3-years with an option to renew, in whole or in part, for a renewal term or terms not to exceed the initial Agreement term of 3-years.

After the execution of the agreement Aetna Life Insurance Company rebranded as Aetna Health Management LLC.
