TITLE: Award Annual Landscape Maintenance & Mowing Contract for Utilities Facilities & Sites

I. MOTION REQUESTED

- A. Award Invitation to Bid No. B200409DWJ, Landscape Maintenance and Mowing of Water, Wastewater, Reuse Facilities and Sites, to primary vendor Tony's Lawn and Landscape LLC and secondary vendor P&T Lawn and Tractor Services, Inc. for maintenance and mowing services, on an as needed basis, as approved in the departments' annual adopted budgets, for an initial term of three years.
- B. Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C. Grant the County Manager or designee the authority to renew the contracts, for up to three additional years, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewals.

II. ITEM SUMMARY

Awards an annual contract to Tony's Lawn and Landscape LLC, as a primary vendor, for an amount of \$432,239.00 and P&T Lawn and Tractor Services, Inc., as a secondary vendor, as a result of a competitive bid solicitation for Landscape Maintenance and Mowing of Water, Wastewater, Reuse Facilities and Sites for Lee County Utilities. The County received six bids and selected the lowest total cost for the primary vendor. The contract does not allow automatic price increases and only allows for negotiated price increases in the event of significant industry-wide market changes. The initial contract is for a three-year period, with the option to renew the agreement, in whole or in part, for a renewal term not to exceed the initial agreement term of three years. Total expenditures for these services for the prior twelve-month period was \$433,451.23

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

Procurement Management obtained bids for the project, known as Invitation to Bid No. B200409DWJ, Landscape Maintenance and Mowing of Water, Wastewater, Reuse Facilities, and Sites. On the bid deadline of October 29, 2020, Procurement Management received six submittals. After conducting an analysis of the bid submissions, Tony's Lawn and Landscape LLC is being recommended as the primary vendor, and P&T Lawn and Tractor Services, Inc., as a secondary vendor, both were determined to be the responsible bidder with the lowest responsive bids.

Staff recommends awarding the annual contract to Tony's Lawn and Landscape LLC, as a primary vendor, for an amount of \$432,239.00 and P&T Lawn and Tractor Services, Inc., as a secondary vendor. This is an 0.3% annual decrease of \$1,212.33 compared to the previous contracted amount. Total expenditures for these services for the prior twelve-month period was \$433,451.23
