I. MOTION REQUESTED

A) Approve the Amendment No. 2 with Aetna Life Insurance Company, under Solicitation No. RFP210494CJV to increase the Individual Stop Loss Amount in the Section 2. Schedule of Insurance of the Agreement from \$425,000.00 to \$450,000.00.

B) Approved the contract renewal for the employee benefits - Medical Stop Loss, from Aetna Life Insurance Company, under solicitation RFP210494CJV, through December 31, 2024.

C) Grant the County Manager or designee the authority to approve the requested price increase, and execute all associated documents, and the amendment, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County.

II. ITEM SUMMARY

Approves an increase to the Individual Stop Loss Amount in the Section 2. Schedule of Insurance of the Agreement with Aetna Life Insurance Company from \$425,000 to \$450,000, for the annual contract for Employee Benefits Medical Stop Loss through December 31, 2024. Total expenditures to provide these services during Fiscal Year 2022-2023 through 11/21/2023, were approximately \$2,504,298. The 2024 premium rate will remain the same at \$48.72 per employee per month.

On December 6, 2022, the Board approved Amendment No. 2 to the Medical Stop Loss Insurance Policy Agreement with Aetna Life Insurance Company under Solicitation No. RFP210494CJV to increase the price for the stop loss coverage.
