THIS FIRST AMENDMENT OF THE PROFESSIONAL SERVICES AGREEMENT FOR MISCELLANEOUS SURVEYING AND MAPPING - ANNUAL, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and KCI Technologies, Inc. ("Consultant"), collectively, the "Parties."
