TITLE: Approve Piggyback for Tire Services Including New and Recapped Tires

I. MOTION REQUESTED

A) Approve Piggyback No. PB190344KLC to utilize pricing on the City of Punta Gorda's R2017112 SVC - Tires/1819 with Boulevard Tire Center, to provide new tire and recapped tire purchases from the State of Florida or FL Sheriffs Association contracts on an as needed basis, through the contract expiration date of December 9, 2023, and any renewals or extensions approved by the City of Punta Gorda. as approved in the departments' annual adopted budgets, in an amount not to exceed \$120,000.00 annually. Individual purchases in excess of \$100,000,00 will be brought to the Board for approval.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

II. ITEM SUMMARY

Approves the use of the City of Punta Gorda contract with Boulevard Tire Center, to provide new tire and recapped tire purchases from the State of Florida or FL Sheriffs Association contract pricing on an as needed basis, through the contract expiration date of December 9, 2023, and any renewals or extensions approved by the City of Punta Gorda. Expenditures during Fiscal Year 2017-2018 were \$119,920.66. Expenditures in future years are not expected to exceed \$120,000.00 annually. A market analysis was completed to identify purchase options available for these products and services. Piggybacking the Punta Gorda contract is the recommended option because of discounted rates for the purchase of tires and the option of repair services including, but not limited to plugs, filling tires with foam, and repairing nail holes. The State of Florida and the Sheriff's Association contracts provided for discounted rates for tires, but did not allow for comparable repair services that are available under the Punta Gorda contract.

Board Action and Other History

The City of Punta Gorda solicited a Request for Proposal that went through the competitive procurement process and negotiations for tire services and recapped tires. A limited number of tire services are made available through the State of Florida and Sheriff's Association contracts. Piggybacking the Punta Gorda contract provides for all the repairs to tires including plugs, filling tires with foam, repairing nail holes, and any other tire repairs necessary.
