Re: Contract Number FSA22-TRS24.0 – Tires: Contract Awards

We are pleased to announce that the Florida Sheriffs Association (FSA) has successfully completed its latest nationwide cooperative bid for tires which has been in existence for 24 years. This contract is in effect beginning April 1, 2022, through March 31, 2024.

This new bid has 12 tire specifications which include:

- Specification 1: Law Enforcement Pursuit and Emergency High Speed Vehicle Tires
- Specification 2: Passenger Vehicle Tires
- Specification 3: Light Truck & Related Vehicle Tires
- Specification 4: Commercial Truck & Related Vehicle Tires
- Specification 5: Off Road Equipment Tires
- Specification 6: Agricultural Farm & Implement Tire
- Specification 7: Specialty Tires
- Specification 8: Off the Road (OTR) Solid Rubber Moulded Tires
- Specification 9: Press on Solid Rubber Tires
- Specification 10: Industrial - Solid Rubber Tires
- Specification 11: Rubber Tracks for Tractors and Equipment
- Specification 12: Re-Tread Tires

The competitive process for this award began in September 2021, when FSA Fleet Advisory Committee, bidders, and stakeholders provided input regarding automotive and equipment procurement needs. Specifications were developed based on prior years activity, and new additions were included based on feedback from the FSA Committee, bidders, and stakeholders.

Advertisements of the Invitation to Bid (ITB) were placed on the FSA website on September 17, 2021, and within the Florida Administrative Register on September 17, 2021, and October 8, 2021.

From the ITB, six bidders completed the pre-bid process. Of these respondents, six submitted bids. Six responsive bidders were awarded after bids were evaluated by the FSA Fleet Advisory Committee and FSA staff.

The Florida Sheriffs Association Cooperative Purchasing Program has followed the Contract Terms and Conditions to procure this contract.

Contract prices are extended and guaranteed to any local government or political subdivision of the state, public educational institutions, other public agencies or authorities with the State of Florida, and other entities approved by the manufacturer to participate in this contract.

Out of state sales are permitted under this contract. All purchasers are bound by their local governing purchasing ordinances, rules and regulations.

All awarded vendors are governed by their manufacturer agreements and the Contract Terms and Conditions.
