# MOTION REQUESTED

A) Approve Piggyback No. PB240123CFC to utilize pricing on the State of Florida Contract No. 56120000-24-NY-ACS for Furniture, All Types with all vendors made part of the contract, for the purchase of furniture (except hospital room and patient handling), on an as-needec basis, through the contract expiration date of December 1, 2028, and any renewals or extensions approved by the State of Florida, as approved in the departments' annual adopted budgets. Individual purchases in excess of \$100,000.00 will be brought to the Board for approval.

B) Grant the County Manager or designee the authority to renew the contract(s) and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewal(s).

#### II. ITEM SUMMARY

Approves the use of the State of Florida Contract for Furniture, All Types to provide purchase of furniture, except hospital room and patient handling, from only the vendors made part of the contract, on an as needed basis, through the contract expiration date of December 1, 2028, and any renewals or extensions approved by the State of Florida. Expenditures during Fiscal Year 2023 were \$213,084.78. Individua purchases in excess of \$100,000.00 will have a market analysis completed and will be brought to the Board for approval.

#### III. BACKGROUND AND IMPLICATIONS OF ACTION

## A) Board Action and Other History

The New York State Office of General Services, Procurement Services Department solicited an Invitation for Bids that went through the competitive process and negotiations for Furniture, All Types. Award was made to all qualified bidders that could provide for conference furniture (seating and tables), dormitory furniture, general purpose tables, high density filing, household furniture, library furniture, office and courtroom furniture, school/higher education furniture (found in classrooms for elementary schools through college), specialty seating (includes big and tall seating, bariatric, gang seating and laboratory stools), systems furniture.

The State of Florida Department of Management Services approved the Alternate Source Contract January 10, 2024. The State of Florida has participating agreements with various firms that were approved under the New York State procurement process. Board approval will provide the County opportunity to purchase furniture from any of the participating vendors through the contract expiration of December 1, 2028, and any renewals or extensions approved by the State of Florida.
