**TITLE:** Approve Piggyback for RapidSOS Premium Ready 4 Annual Subscription

**I. MOTION REQUESTED**

- A) Approve Piggyback No. PB240367SSL to utilize pricing on the General Services Administration (GSA) Contract No. GS-35F-0594S for Multiple Award Schedule (MAS) Large Category F: Information Technology, for the purchase of RapidSOS Premium Ready 4 Annual Subscription, through the contract expiration date of June 17, 2025.
- B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C) Grant the County Manager or designee the authority to renew the contract(s) and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewal(s).

**II. ITEM SUMMARY**

Approves a piggyback to use pricing on the General Services Administration (GSA) contract for Multiple Award Schedule (MAS) Large Category F: Information Technology, to purchase RapidSOS Premium Ready 4 Annual Subscription. This software and technology connects to the County's Next Generation 911 system to provide additional features, including data from mobile phones, connected alarms and other devices, and system redundancies. A market analysis was completed and the purchase under this contract will represent a savings of 13.098% or \$19,569.00. The agreement has a one-year term, with an option for future renewals within the department's annual budget.

**III. BACKGROUND AND IMPLICATIONS OF ACTION**

A) Board Action and Other History

RapidSOS works with over 5,200 emergency communications centers and supports over 250 million emergency calls annually. The platform sends critical location and additional data to first responders through the emergency response platform. Partners, who range from home security systems and connected healthcare platforms to telematic systems and wearable health devices, share incident-specific data through this platform.

This piggyback purchase utilized the GSA Contract to purchase the Premium offering of the software for the County's five Public Safety Answering Points. This will enable these additional features at each location where 911 calls are answered.

A market analysis was completed and the purchase under this contract will represent a savings of 13.098% or \$19,569.00. The agreement has a one-year term, with an option for future renewals within the department's annual budget.
