TITLE: Approve Annual Piggyback for Purchase of Tires Tubes and Services

I. MOTION REQUESTED

- A. Approve Annual Piggyback No. PB250057CFC to utilize pricing on the State of Florida Participating Agreement (Alternate Contract Source No. 25172500-24-ACS) through the NASPO ValuePoint Solicitation No. RFP0223005113, for the purchase of tires, tubes and services countywide from Bridgestone Americas Tire Operations, LLC, The Goodyear Tire and Rubber Company and Michelin North America, Inc., on an as-needed basis, through the contract expiration date of March 31, 2027, and any renewals or extensions approved by State of Florida, as approved in the departments' annual adopted budgets.
- B. Authorize the County Manager or designee to execute any contract documents on behalf of the Board of County Commissioners.
- C. Grant the County Manager or designee the authority to renew the contracts, for up to three additional years, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County.

II. ITEM SUMMARY

Approves using a cooperative purchasing agreement authorizing use of the State of Florida Contract through a competitively bid NASPO ValuePoint solicitation for the purchase of tires and related products and services on an as-needed basis. The contract will be available for countywide use, as approved in the departments' annual approved budgets. Approval allows the County to purchase a wide selection of these products and services at competitive pricing through multiple vendors. Total expenditures for tires and related services and equipment for Fiscal Year 2023-2024 were \$424,391.32 mostly by the Fleet and Solid Waste departments.

III. BACKGROUND AND IMPLICATIONS OF ACTION

The State of Iowa solicited proposals in collaboration with NASPO ValuePoint for their Request for Proposal RFP0223005113 Tires, Tubes, and Services. After completing the competitive solicitation process, contracts were awarded to Bridgestone Americas Tire Operations, LLC, The Goodyear Tire and Rubber Company and Michelin North America, Inc. Participating addenda were completed with the State of Florida for Bridgestone Americas Tire Operations, LLC, The Goodyear Tire and Rubber Company and Michelin North America, Inc. The contracts with the addenda provide the option of cooperative purchasing, authorizing Lee County to piggyback the contracts for purchases countywide.
