I. MOTION REQUESTED

A) Award Invitation to Bid No. B240216WCD, Purchase of Ballfield Clay Products and Conditioners to provide ballfield clay products to Lee County baseball and softball fields on an as-needed basis for a period of three years, as approved in the departments' annual adopted budget to the following vendors: Ewing Irrigation Products, Inc., SiteOne Landscape Supply, LLC., and Rentokil dba Target Specialty Products, Inc. Individual purchases in excess of \$100,000.00 will be presented to the Board for approval.

- B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C) Grant the County Manager or designee the authority to renew the contract(s), for up to two additional years, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County.

II. ITEM SUMMARY

Awards competitively solicited contracts to Ewing Irrigation Products, Inc., SiteOne Landscape Supply, LLC., and Rentokil dba Target Specialty Products, Inc. to purchase ballfield clay products. These products will be used to maintain professional and amateur standards at the Lee Health Sports Complex, JetBlue Park, Terry Park and all other Community Park baseball and softball fields. Purchases will be on an as-needed basis for a period of three years with the option to renew for up to two additional years.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

On March 15, 2024, Procurement Management advertised B240216WCD Purchase of Ballfield Clay Products & Conditioners for Lee County to obtain bid submissions for purchase of ballfield clay products and conditioners on behalf of the Board of County Commissioners. On the bid deadline of April 17, 2024, Procurement Management received five bid submissions. Based on the bid submission pricing, it is recommended each category be awarded to a primary and secondary vendor to the firm that supplied the lowest pricing for the associated category as defined below:
