

FIRST AMENDMENT OF THE AGREEMENT FOR REMOVAL

THIS FIRST AMENDMENT OF THE AGREEMENT FOR REMOVAL OF DERELICT AND ABANDONED VESSELS, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Emerge Marine, LLC ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of derelict and abandoned vessel removal services through Solicitation RFP210083CJV with Vendor on the 3<sup>rd</sup> day of February, 2022 ("Agreement"); and,

WHEREAS, on the date the Agreement was executed, the Vendor's business entity name was Andros Boatworks, Inc., with a Federal Tax ID Number of 20-2759736; and,

WHEREAS, after execution of the Agreement, Andros Boatworks, Inc. formed Emerge Marine, LLC, with a Federal Tax ID Number of 84-3360265, and moved their marine recovery services under the Emerge Marine, LLC company; and,

WHEREAS, County and Vendor desire to enter into this First Amendment to continue their Agreement via Solicitation No. RFP210083CJV under the Vendor's new entity.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Vendor, conducting business as Emerge Marine, LLC, shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. RFP210083CJV, including appendices and amendments, and Vendor's response.
