### I. MOTION REQUESTED

A) Award Request for Proposal No. RFP210140BAG, VCB Tourism Advertising, Program Planning, Creation & Implementation to MMGY Global, LLC for professional marketing services, on an as needed basis, for an initial term of one (1) three (3) year period, in an amount Not to Exceed \$12,559,715.00 annually.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to renew and renegotiate the contract, within the annual Not to Exceed amount of the contract, for up to three (3) additional years, and to execute all associated documents, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewal(s).

### II. ITEM SUMMARY

Approves the ranking of firms and authorizes the execution of a contract with the top ranked firm, MMGY Global, LLC, for VCB Tourism Advertising, Program Planning, Creation and Implementation, in an amount not to exceed \$12,559,715 for Fiscal Year 2021-2022. Provides the Visitor and Convention Bureau (VCB) with comprehensive advertising services to promote Lee County as a leading tourism destination. The initial contract term is three years and the fees will be negotiated annually.

#### III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

MMGY Global, LLC is the incumbent vendor currently providing Lee County VCB professional marketing services, on an as needed basis under Solicitation No. RFP160255 adopted by the Board on September 20, 2016 which expires on September 30, 2021.

Lee County Visitor & Convention Bureau submitted a request to Procurement Management to obtain proposals on behalf of the Board of County Commissioners for the project known as RFP210140BAG, VCB Tourism Advertising, Program Planning, Creation & Implementation. On the established proposal deadline of March 30, 2021, Procurement received five proposals. An evaluation meeting was held on May 6, 2021 during which the Evaluation Committee considered criterion as listed in the solicitation request including such items as Tourism Industry Experience and Qualifications, Firm Creative Strengths, Plan of Approach for Media Buying, Personnel/Resources, and Detailed Proposal. On the basis of the information submitted by the firms in their proposals, it was the consensus of the Committee to recommend to the Board the ranking as follows: 1) MMGY Global, LLC 2) Starmark International 3) Hoffman York.

The services provided by MMGY Global, LLC have been valuable to Lee County and effective at furthering the goals of the VCB for tourism promotion efforts.
