**SECOND AMENDMENT OF THE AGREEMENT FOR  
 DISASTER DEBRIS MONITORING FOR LEE COUNTY**

THIS SECOND AMENDMENT OF THE AGREEMENT FOR DISASTER DEBRIS MONITORING FOR LEE COUNTY, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") Thompson Consulting Services, LLC ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of disaster debris monitoring services through Solicitation No. RFP210330BJB with Vendor on the 4<sup>th</sup> day of March, 2022 ("Agreement"); and,

WHEREAS, after the execution of the Agreement, the County determined that debris monitoring services for North Captiva Island and Cayo Costa Island were necessary; and,

WHEREAS, the debris monitoring services for North Captiva Island and Cayo Costa Island will require the utilization of one or more boats with captains and utility vehicles; and,

WHEREAS, pursuant to Article XV. MISCELLANEOUS of the Agreement, the Parties desire to update the Exhibit B. Fee Schedule to add items for boats with captains and utility vehicles.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that, effective immediately upon full execution of the Agreement, the Exhibit B. Fee Schedule of the Agreement shall be superseded by the following:
