**RE: NOTICE OF TERMINATION – RFP210553WCD- AGREEMENT FOR FORT MYERS BEACH PIER CONCESSIONS**

Dear Ms. Bell:

On April 12, 2022, Lee County entered into an Agreement, with Seaside Kayaking LLC, under Solicitation No. RFP210553WCD, for concession services to be provided at the Fort Myers Beach Pier. As a result of Hurricane Ian's destruction of the Fort Myers Beach Pier, the Agreement can no longer be performed, and will not be able to be performed until further notice.

As a result, pursuant to Section 11. AMENDMENT AND TERMINATION, of the Agreement for Fort Myers Beach Pier Concessions, the County is terminating the Agreement, effective February 5, 2023. Furthermore, because of the termination resulting from the destruction of the Fort Myers Beach Pier, the County is immediately suspending the requirement for any additional payments to be made from Seaside Kayaking, LLC, under the Agreement.
