SECOND AMENDMENT OF THE AGREEMENT FOR CUSTODIAL SERVICES SOUTH ZONE

THIS SECOND AMENDMENT OF THE AGREEMENT FOR CUSTODIAL SERVICES

SOUTH ZONE, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") United States Services Industries, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of custodial services for South Lee County through Solicitation No. RFP220314SML with Vendor on the 16th day of March, 2023 Agreement"); and,

WHEREAS, after the execution of the Agreement the South County Regional Library service location was scheduled for a renovation and will be temporarily closed to the public on September 7, 2024; and,

WHEREAS, a temporary location for the South County Regional Library will be opened in a 525 sqft room within the Three Oaks Park building located at 18251 Three Oaks Pkwy, starting September 16, 2024; and,

WHEREAS, custodial services will be temporarily stopped during the renovation at the current South County Regional Library service location and custodial services are needed at the temporary location for the South County Regional Library, located at 18251 Three Oaks Pkwy; and,

WHEREAS, the cleaning services moving from the South County Regional Library to the temporary South County Regional Library will result in a decrease of \$3,066.14 in the monthly cost for that location; and,

WHEREAS, pursuant to Article V. ADDITIONAL PURCHASES of the Agreement, the Parties desire to temporarily stop the porter service at the South County Regional Library location effective September 8, 2024, temporarily stop all custodial services at the current South County Regional Library location effective September 29, 2024, and add custodial services for the temporary location for the South County Regional Library effective September 16, 2024, within Section 18. LOCATIONS of the Exhibit A, SCOPE OF WORK, and the Exhibit B, FEE SCHEDULE of the Agreement, effective immediately upon execution of this Amendment by all Parties.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

- The Parties agree that, beginning September 8, 2024, porter services for Location D. South County Regional Library within Section 18. LOCATIONS of the Exhibit A, SCOPE OF WORK will be temporarily stopped until official notice is given by the County.
- The Parties agree that, beginning September 29, 2024, the custodial services for Location D. South County Regional Library within Section 18. LOCATIONS of the Exhibit A, SCOPE OF WORK will be temporarily stopped until official notice is given by the County.
- 3. The Parties agree that, effective September 16, 2024, the following locations table shall supersede the existing locations table in Section 18. LOCATIONS of the Exhibit A, SCOPE OF WORK of the Agreement:
