FIRST AMENDMENT OF THE AGREEMENT FOR CUSTODIAL SERVICES SOUTH ZONE

THIS FIRST AMENDMENT OF THE AGREEMENT FOR CUSTODIAL SERVICES SOUTH ZONE, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") United States Services Industries, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of custodial services for South Lee County through Solicitation No. RFP220314SML with Vendor on the 16th day of March, 2023 ("Agreement"); and,

WHEREAS, it was discovered after the execution of the Agreement that it would be in the best interest of the County to increase the frequency of cleanings at the Sheriff Substation – South District service location from five times per week to seven times per week, within the Exhibit A, SCOPE OF WORK of the Agreement; and,

WHEREAS, the increase from five days of cleaning services to seven days at the Sheriff Substation – South District will result in an increase of \$487.63 in the monthly cost for that location; and,

WHEREAS, after the execution of the Agreement the Sheriff Substation – South District service location was renamed the Sheriff Substation – 4^{th} Precinct; and,

WHEREAS, pursuant to Article V. ADDITIONAL PURCHASES of the Agreement, the Parties desire to increase the frequency of cleanings at the Sheriff Substation – South District and rename the Sheriff Substation – South District service location, within Section 18. LOCATIONS of the Exhibit A, SCOPE OF WORK, and the Exhibit B, FEE SCHEDULE of the Agreement, effective immediately upon execution of this Amendment by all Parties.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that, effective upon full execution of this Amendment by all Parties, all references to the Sheriff Substation – South District within the Agreement shall be replaced by the name: Sheriff Substation – 4th Precinct and that the following locations table shall supersede the existing locations table in Section 18. LOCATIONS of the Exhibit A, SCOPE OF WORK of the Agreement:

Scheduling

- a. Lee County, working with the Vendor, may designate the time during which selected areas shall be cleaned.
- b. Cleaning shall be performed on a seven days per week basis, exclusive of holidays.
- c. All work is to be done between the hours of 8:00am and 3:00pm, the building closes at 5:00pm and there shall be no regular cleaning after hours, unless otherwise instructed/approved by the County Facility Manager.
- d. The Vendor will be given a minimum of 48 hours' notice of any schedule change.
- e. Special cleaning tasks such as stripping, waxing, and shampooing of carpets can only be done after 7:00 p.m. on a weeknight with two weeks advance notice to the office manager of the facility.
- f. No cleaning or special work can be scheduled during a holiday.
- g. There are offices within the facility that remain closed unless there is someone occupying it at the time of cleaning. The personnel in those offices will let the cleaner know if and when they can clean completely or if they just want their trash removed.
- h. At the present time, trash cannot be removed from the building until the back door is opened by a Sheriffs staff member. The staff member will stay with the cleaner until the cleaner comes back inside the building. This needs to be coordinated with Sheriff staff during each cleaning service visit.
- Crew scheduling is the Vendor's responsibility and should be arranged so as not to interfere
 with day-to-day business operations. Crews will schedule according to the Sheriffs holiday
 observance for this building.
- j. If special project work is scheduled for the evening, the Vendor shall coordinate with the Sheriff's department to allow as much time as necessary to perform all functions.
- k. Special Events: Occasionally, a special event may be held in this facility that will require that the Vendor to clean after the event is complete. These events are not common and rarely occur. These events would be quoted in advance and on a separate invoice.
- 1. Saturday/Sunday cleanings shall be specifically for service in the following areas: kitchen, restrooms, common walkways and lobby, roll call room, and removal of all trash.

Reimbursement of Consumables

The Vendor shall be reimbursed by the County at Vendor's cost for consumable supplies. To be eligible for reimbursement for consumables purchased, the Vendor shall provide the County with sufficient documentation with respect to materials purchased and used for County facilities in a form acceptable to the County, as determined by the Director of Procurement Management. Such documentation shall provide proof of payment and the unit prices for the consumables purchased. Vendor invoices for consumables must contain at a minimum a description of the materials purchased, the quantity delivered to the facility and unit cost associated with each item.
