

FIRST AMENDMENT OF THE AGREEMENT FOR WASTEWATER
COLLECTIONS SYSTEM REHABILITATION

THIS FIRST AMENDMENT OF THE AGREEMENT FOR WASTEWATER COLLECTIONS SYSTEM REHABILITATION, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Insituform Technologies, LLC ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of wastewater collections system rehabilitation services through Solicitation B230154DWJ with Vendor on the 30th day of June, 2023 ("Agreement"); and,

WHEREAS, on the date the Agreement was executed, the Vendor's business entity name was Miller Pipeline, LLC, with a Federal Tax ID Number of 35-1959522; and,

WHEREAS, after execution of the Agreement, Miller Pipeline, LLC was acquired by and began operating as Insituform Technologies, LLC, with a Federal Tax ID Number of 13-3032158; and,

WHEREAS, County and Vendor desire to enter into this First Amendment to continue their Agreement via Solicitation No. B230154DWJ under the Vendor's new business name.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Vendor, conducting business as Insituform Technologies, LLC, shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. B230154DWJ, including appendices and amendments, and Vendor's response.
